### Mass. Financial Aid Overview & Process

Students apply by completing the **FAFSA** (Free Application for Federal Student Aid) or **MASFA** (Massachusetts Application for State Financial Aid)

MA FAFSA annual completion rates have declined since the COVID emergency, going from a high of **359,000 to an average of 325,000** 

Near doubling of financial aid from \$185M in FY23 to \$344 M in FY24

MA FAFSA completion is down, and there is more state and federal aid than ever before available students

# **Historic Opportunity**

Near-doubling of financial aid allows MA to provide:

- ✓ **Zero tuition and fees** for Pell Grant-eligible students at all public 2 and 4-year campuses
- √ \$1,200 allowance for books and supplies for Pell Grant-eligible students at public institutions
- ✓ Up to half off out-of-pocket expenses for moderate income students at public institutions
- ✓ **Zero tuition and fees** for community college students 25 and over without a degree
- ✓ Tuition Equity for students who are undocumented and qualify as "High School Completers"





# FAFSA Completion Down Since Last Year

As of June 7, 2024, the National College Attainment Network (NCAN) estimates:


√ 48 percent of Massachusetts seniors had completed the FAFSA, above 44.1 percent nationally

✓ Massachusetts is 13.1 percent below this point last year – that's about 6,000 fewer seniors completing the FAFSA







#### **FAFSA Completion by Race Since 2019**




### Low Income vs Non Low Income FAFSA Completion 2019 - 2024

# National FAFSA Completion Initiatives

**Graduation Requirements:** FAFSA completion is required to graduate high school in 12 states, including California, Louisiana, Texas, Nebraska, Maryland, Illinois, Colorado, and New Hampshire

Requirements vary and most include an opt-out clause

#### **Innovative Public Awareness Campaigns**

- Illinois College Changes Everything
- Tennessee Finish the FAFSA Week
- Kentucky Kentucky Goes to College

**Assistance and Training:** FAFSA assistance and training offered to agencies, school counselors, and others to equip them with tools to help students access financial aid

**Extended 2024 Deadlines:** Most states have also extended their deadlines for state financial aid





# States with Universal FAFSA Observe Higher Completion Rates than MA

Illinois	53.8%
Texas	52.1%
Connecticut	50.3%
New Jersey	48.8%
California	48.4%
Massachusetts	47.5%

- Family members and other stakeholders who influence students' college-going decisions



# Targeted Data for Direct Student Outreach

- Long-term data sharing partnership between DHE and DESE
- Schools access FAFSA tracking to monitor submission and completion by high school seniors
- Schools are encouraged to develop tracking processes for newly launched MASFA completion
- FAFSA data in EDWIN Analytics is updated 3 times per week

Six-week web & social ad campaign to promote online FAFSA support sessions led by FAFSA Day MA and MassEdCO, in partnership with MEFA












# FAFSA Completion Web and Social Campaign

The Free Application for Federal Student Aid (FAFSA) form is the key to unlocking college financial aid from federal, state, and local sources. If your immigration status prevents you from qualifying for federal aid, you might still be eligible for aid through the Massachusetts Application for State Financial Aid (MASFA), which can help you attend public institutions of higher education in Massachusetts. Apply for financial aid helps keep college an option for the fall but does not commit you to enrolling. Fill out the FAFSA or MASFA as early as possible to maximize the aid you'll













# **Next Steps**

#### **Enhance Awareness and Accessibility**

 Scale strategies to increase awareness of college affordability and new state financial aid options for students & families.

#### **Boost FAFSA and MASFA Completion Rates**

 Focus on increasing FAFSA and MASFA completion rates through targeted initiatives, ultimately aiming to raise collegegoing rates.

#### **Innovative Student Engagement**

 Explore and pilot technology-enabled engagement strategies to better communicate financial aid availability and benefits to students.

#### **Policy and Reporting Initiatives**

 Examine policies such as mandatory FAFSA completion and produce an annual joint report detailing completion rates by student groups and summarizing interagency collaboration efforts.

# State Financial Aid – College Affordability

 Historic Investment in State Financial Aid by the Massachusetts Legislature

 Goal is to make college more affordable for the direct cost of tuition, fees and books at all public colleges and universities, for all low-income (Pell eligible) students

 Programs also serve to reduce out-of-pocket expenses for students from middle-income families

### **Cost of Attendance**

- What does true affordability mean?
  - Current goal is Tuition, Fees, Books & Supplies
- Total Cost of Attendance
  - Tuition, fees, books and supplies
  - Room and Board
  - Childcare, transportation, medical, miscellaneous, etc.
- Should affordability include the full Cost of Attendance (COA)?
- Who should be assisted by State Financial Aid?
  - Low-income/poverty level, Pell eligible students
  - Middle income students with Adjusted Gross Income cap
  - Merit students

# **FAFSA Completion**

- Rollout of the new and better FAFSA has created challenges for students and families nationwide, specifically first-generation students
  - Significant decline overall in the number of FAFSA filers
  - Massachusetts seeing an 18-20% decline
- DHE extended the FAFSA priority deadline from May 1<sup>st</sup> to July 1<sup>st</sup> for the MASSGrant program
  - Students may complete the FAFSA after July 1st to qualify for other programs, such as MASSGrant Plus and MASSGrant Plus Expansion
- DHE, DESE, MEFA, MASFAA and GEAR UP, held webinars and workshops to help students and families complete the FAFSA.



### **FAFSA Completion Incentive Project**

- Launched in partnership with DESE
- Targets the 26 Gateway Communities
  - 108 public and charter schools serving 3,500 high school seniors
  - Concentration of historically underrepresented and underserved populations
  - Annually a 50% FAFSA Completion rate
- DHE implemented a communications strategy that will run through August 2024 with specific messaging encouraging students that it is not to late to apply, and that financial aid is available



### Financial Aid Overview and Process

- Massachusetts students apply for state financial programs by completing the FAFSA or MASFA
- Annually, an average of 325,000 Massachusetts students complete a FAFSA
- July 1<sup>st</sup> is the priority deadline for the Commonwealth's primary need-based program, the MASSGrant\_
- State Financial Aid is processed through MASSAid, an online financial aid system accessible by students and institutions
- More state and federal aid than ever before is available to Massachusetts public high school students

## Main State Financial Aid Programs


- Financial aid programs that support the cost of tuition, fees, books and supplies include the following:
  - MASSGrant: Public and private colleges and universities
  - MASSGrant Plus: Public college and university students
  - MASSGrant Plus Expansion: Public colleges and universities only
    - Pell Grant-eligible students receive free tuition and fees and \$1,200 allowance for books and supplies
    - Out-of-pocket costs reduced by up to half for middle income students (adjusted gross income between \$73,000 and \$100,000 annually)






# For Most Groups, FAFSA Completion Is Still Behind Pre-Pandemic Levels
