Notice is hereby given pursuant to M.G.L. c. 69, § 30 and the Massachusetts Board of Higher Education's Policy Establishing a Process for Public Comment on Articles of Organization and Foreign Certificates of Institutions of Higher Education that the Massachusetts Department of Higher Education will open a comment period relative to the Articles of Amendment filed by Endicott College to offer the Master of Science in Physician Assistant Studies.

Endicott College was founded in 1939 as a private, two-year women's college by Dr. Eleanor Tupper and Dr. George Bierkoe. In 1988, the College applied for and earned status as a four-year institution and completed the transition in fall of 1997. In 1993, the College decided to transform into a co-educational institution, with the first co-ed class admitted in Fall of 1994.
